

# **Africa Travel Summit**

## **Application & Participation Terms**

THESE TERMS GOVERN YOUR APPLICATION FOR THE AFRICA TRAVEL SUMMIT AND YOUR ATTENDANCE AT OR PARTICIPATION IN ALL EVENTS RELATED TO THE SUMMIT

The organisers of the Africa Travel Summit include Airbnb. The Africa Travel Summit may include participation or presentations by third parties, companies or organisations. Such participation or presentations represent the views of the individuals or entities concerned, and their inclusion does not indicate that they are approved or endorsed by Airbnb or any of the other organisers.

By applying to attend the Africa Travel Summit, you accept and agree to comply with all applicable laws, these Terms, and any terms, instructions or requirements applied by Airbnb, other organisers and/or the Summit venue(s). Additional information regarding the Summit can be found [here](#).

### **Applications/Invitations**

Unless personally invited by Airbnb or the organisers, all prospective attendees must first apply to attend the Africa Travel Summit. Application forms are available at [www.airnbcitizen.com](http://www.airnbcitizen.com).

Attendance eligibility rules apply. Information regarding eligibility will be updated from time to time and published at [www.airnbcitizen.com](http://www.airnbcitizen.com). Airbnb or the organisers may accept or reject your application at their discretion for any reason, without being obliged to give any explanation.

If your application is accepted you will be invited to the Summit. Invitations are individual.

Attendees are not permitted to bring uninvited guests. Invitations may not be transferred to any other person or redeemed for cash or any other item. For the avoidance of doubt, invitations do not imply that Airbnb or the organisers will pay any of attendees' accommodation, transport or other expenses, which are solely for attendees, except where expressly agreed in writing by Airbnb or the relevant organiser.

You agree that you will not issue any press release or make any public statement about the Summit or your application at any time without Airbnb's prior consent.

### **Attendance at the Africa Travel Summit**

Airbnb and the organisers reserve the right to revoke attendees' invitations, or to require them to leave any Africa Travel Summit venue, for any reason.

### **Security at the Africa Travel Summit**

Airbnb and the organisers may, but are not obliged to, take certain security measures at the Africa Travel Summit. Attendees who fail to respect the instructions of security personnel may

be removed from the Africa Travel Summit event or any Summit venues and may have their invitation and permission to attend revoked at the organisers' discretion.

### **Presentations and Materials**

If attendees are requested or required to make any presentations or materials for the Africa Travel Summit, then additional terms and conditions may apply and will be communicated to you. In general all such items must be original works, contain no obscene, discriminatory, violent or illegal or inciting content, comply with all applicable laws and regulations, and not breach any rights of third parties. Attendees will grant to Airbnb and the organisers a non-exclusive, royalty-free, transferable license to use such materials.

### **Publicity release**

By applying for or attending the Africa Travel Summit, you agree that Airbnb and the organisers may record or photograph the event (including you, your likeness, and voice), and you grant Airbnb and the organisers an irrevocable, unrestricted, perpetual, non-exclusive and sub licensable license, to take, use, display, perform, distribute, or exploit any such material for any lawful and commercial purpose.
